


The Season of the Great Return

TRAINING FOR TODAY & TOMORROW

Ballet Co.Laboratory believes in the development of the whole dancer and works to invest in each artist's present and future work in the art form.

Due to the extreme demands on the body, a career as a professional ballet dancer is relatively short. On average, dancers retire from their full-time performance careers by the time they are 35. Knowing this, Ballet Co.Laboratory created a forward-thinking arts administration training program for its professional dancers.

Within a Company member's role as a professional dancer, they are paid in addition to their artist wages to develop and enhance their skills in arts administration. Upon hire, Ballet Co.Laboratory Managing and Artistic Directors meet with each Company dancer to discuss their future goals. Each artist's unique skill set and passions are taken into account to identify what arts administration role they might enjoy. After a dancer identifies their area of interest in outreach, marketing, fundraising, education, technology, or production, they work alongside a seasoned professional to develop expertise.

This program not only creates a dedicated sense of ownership in all aspects of the organization but also helps artists build a strong resume to prepare for the next chapter of their careers after Company life.

Charlotte Tracy, a dancer at The School of Ballet Co.Laboratory had a different milestone to celebrate prior to donning a cap and gown – her final performance as a Trainee with the professional Company of Ballet Co.Laboratory in Firebird.

The Trainees of Ballet
Co.Laboratory are advanced
level students of The School
of Ballet Co.Laboratory (ages
15-22) who audition to study
alongside the Company four
times a week in addition
to their School training.
This experience allows preprofessional students the
opportunity to explore the life
of a professional dancer.

"Most kids my age have a lot more free time, but I wouldn't have exchanged being a Trainee for anything. I consider my front-row seat to the inner workings of a professional ballet company a distinct privilege. I feel incredibly prepared going into a college dance program next year because of what I've learned at Ballet Co.Laboratory."

Charlotte will begin her first year at the University of Missouri – Kansas City's dance program this fall.



COMMUNITY ENGAGEMENT & ACCESS

A crucial component of re-imagining ballet for the 21st century is working to ensure ballet continues to expand in diversity and accessibility. Ballet Co.Laboratory invests in this work by bringing dance performances and workshops into communities throughout the Twin Cities that have limited access to dance programming. For many, this is their first experience with the performing arts.

At Ballet Co.Laboratory, we understand that dance instruction is not financially accessible for everyone. To aid in the access to dance education, collaborators of Ballet Co.Laboratory donate to help fund need-based scholarships and Work Exchange programs that gift the chance to dance.

Ballet Co.Laboratory's performance of *The Four Seasons & Other String Pairings* was our organization's first opportunity to perform a full-length ballet alongside musicians. Even more noteworthy, one of those musicians is an adult student at The School of Ballet Co.Laboratory.

Helen Chang Haertzen is a Minnesota Orchestra violinist and ballet enthusiast. She credits her ongoing ballet training in becoming a better musician, stepping into her artistic choices with more confidence because of her viewpoint from the barre.

As a child, Helen began violin lessons at age 5, only beginning recreational dance training in high school. After joining the esteemed Minnesota Orchestra as an adult, she began to take classical ballet more regularly. Helen considers the ballet studio a sanctuary that has helped energize her to approach playing with the same intention that it takes to perform movements in a ballet class.

"I always think the care that dancers use to get each detail right is inspiring," Helen remarked. "I have noticed that I play [violin] better when I take [ballet] class at least once a week. It helps me find a focus to better approach my music. There is something special about dancing with a community of like-minded individuals from all walks of life looking to continually improve together."











Campaign Update

Breaking Ground | Expanding Artistry

In August 2021, Ballet Co.Laboratory announced a three-phase fundraising campaign to expand our training and performance space. Nearly 200 individual donors came together this season to contribute \$75,000. With a portion of these funds, Ballet Co.Laboratory was able to complete Phase I of this expansion which included the build-out of two additional rehearsal studios and office space, construction of marley covered sprung dance floors, painting of new spaces, installation of mirrors, barres, and sound systems. The completion of Phase I gifted our Company and School a space large enough for full cast rehearsals and the ability to accept new students with room to grow.

Our organization continues to raise funds for Phase II of this campaign which includes the build of a 150-seat performance venue (the Ballet Co.Laboratory Studio Theatre) within our current home. Each season, Ballet Co.Laboratory rents various theater venues to present our five large-scale productions, four school showcases, and one benefit performance. Through this rental process, Ballet Co.Laboratory has found that there are very few small to mid-size theater spaces not tied to a college, university, or resident performance group with their own full season of programming. What results is a scarcity of available performance dates and extremely high rental rates.

The creation of Ballet Co.Laboratory's Studio Theatre will help our organization reduce theater rental expenses, increase revenue with the ability to expand our performance season, and offer artists in our community an affordable space to create and present their work.

It is our desire to become a center for dance where multigenerational students, professional artists, and arts patrons alike can all go to witness, explore, learn, teach, create, and present the art of dance.




